### **SOUTH FLORIDA WINDSURFING ASSOC. INC. MEMBERSHIP APPLICATION EXPRESS WAIVER OF RIGHTS, ASSUMPTION & ACKNOWLEDGEMENT OF RISKS RELEASE OF LIABILITY AND INDEMNITY AGREEMENT**

On behalf of myself, my spouse and any minor children for whom I am parent, legal guardian or otherwise responsible, and for my/our heirs, personal representatives or assigns I hereby acknowledge and agree in consideration of and in return for my/our SFWA membership and participation in SFWA events and activities including sailing or launching at Crandon Park or other launches as follows:

1. **ACKNOWLEDGEMENT OF RISKS.** I acknowledge that WINDSURFING AND WATER RECREATIONAL ACTIVITIES ARE VERY DANGEROUS and involve the risk of SERIOUS INJURY and/or DEATH. Risks include, but are not limited to changing tides and water flow, collisions, capsizing, inclement weather, equipment failure, operator error, all of which can cause serious injury, paralysis and/or death.
2. **EXPRESS ASSUMPTION OF RISK AND RESPONSIBILITY.** I agree to assume responsibility for all the risks of the activity, whether expressly stated above or not, EVEN THOSE RISKS ARISING OUT OF THE NEGLIGENCE OF THE RELEASEES NAMED BELOW. My/our participation in the activity is purely voluntary. I assume full responsibility for myself, my spouse and any minor children for whom I am responsible, for any bodily injury, accident, illness, paralysis, death or loss of personal property even IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE RELEASEES NAMED BELOW, to the fullest extent permitted by law. I understand that I am the only person authorized to windsurf, and I will not allow anyone else to operate the windsurfer. I agree to wear a U.S. Coast Guard approved flotation device (life jacket), if required by state statute or local ordinance, while windsurfing and will also require any passengers to wear a life jacket. I am familiar with and will comply with all rules and regulations for safe operation of the windsurfer.
3. **RELEASE.** I hereby release The South Florida Windsurfing Association, Inc., its principals, directors, officers, agents, employees and volunteers, and each and every landowner, municipal and/or governmental agency upon whose property an activity is conducted ("owner"), if any, (Collectively "Releasees") FROM ANY AND ALL LIABILITY OF ANY NATURE FOR ANY AND ALL INJURY OR DAMAGE (INCLUDING DEATH) TO ME OR MY MINOR CHILDREN OR ANY OTHER PERSONS as a result of my/our participation in any SFWA activity or sailing or launching at Crandon Park or elsewhere, EVEN IF CAUSED BY THE NEGLIGENCE OF ANY OF THE RELEASEES NAMED ABOVE OR ANY OTHER PERSON (INCLUDING MYSELF) to the fullest extent permitted by law.
4. **INDEMNITY.** I hereby agree to INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them FROM ANY LOSS, LIABILITY, DAMAGE OR COST they may incur arising out of or related to the use of any watercraft provided to me, or arising out of or related to my participation in any WINDSURFING or water recreational activity, WHETHER CAUSED BY MY NEGLIGENCE OR THE NEGLIGENCE OF OTHERS. I HAVE READ THE ASSUMPTION AND ACKNOWLEDGEMENT OF RISKS, RELEASE OF LIABILITY, AND INDEMNITY AGREEMENT. I UNDERSTANT THAT BY SIGNING THIS DOCUMENT, I AM WAIVING VALUABLE LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE THE RELEASEES, THE ENTITIES NAMED ABOVE, OR THEIR EMPLOYEES, AGENT, SERVANTS OR ASSIGNS AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE AND INDEMNITY TO THE GREATEST EXTENT ALLOWED BY LAW.
